Ocean Park (The Park) Nature Explorer Junior Seasonal Adventure Series – "Mini-Rangers" Terms and Conditions

(A) Criteria for Participation

- 1. "Mini-Rangers" is suitable for children aged 4 to 5.
- 2. All participants must be paid. No accompanying guest is allowed (include children who are under age of 3).
- 3. Participants who are suffering from any disease (including, but not limited to fever, coughing, cold/flu, skin disease, fainting/giddiness/ loss of consciousness when in close contact with animals, phobia of water, allergy or depressed immune mechanisms), under the influence of medication and/or alcohol are not recommended to participate in this programme.
- 4. Participants must not be suffering from any infectious disease Remark 1 specified in the First Schedule to the Prevention and Control of Disease Ordinance (Cap 599 of the laws of Hong Kong).
- 5. To safeguard all participants, sick participants will be requested to stay home. Ocean Park reserves the right to request sick participants to leave the programme in case of such necessities.
- 6. If a situation arises where a participant threatens the safety or security of other participants, or if a participant shows disregard of programme guidelines, we will make every appropriate effort to communicate with the parents to handle the participant's behaviour. Should the disruptive behaviour continue, the participant may be dismissed from the programme and should leave the Park with his/her parents at the discretion of Ocean Park. The Park will not be held responsible for any cost associated with a child's dismissal on the ground of disruptive behaviour.
