



海洋公園 「換」然一新纜車 STEM 工作坊 條款及細則

參加者資格及條件

- 1. 參加者必須年滿 6 歲或以上。
- 2. 合資格的 6-11 歲之參加者必須由已報名並符合參加本活動要求的家長/監護人陪同參與。每位家長/監護人最多可陪同一位合資格的 6-11 歲之參加者進行活動。
- 本活動之費用並不包括入場門票,參加者必須持有活動當日有效之海洋公園入場門票。
- 4. 本活動不接受隨行訪客(包括6歲以下小童)。
- 5. 每位參加者必須填寫及簽署一份豁免責任書。
- 6. 合資格而未滿 18 歲之參加者,須於活動開始之前,由其家長/監護人加簽以確認同意豁免責任書之內容。
- 7. 此活動僅接受以2人為單位之報名,即1至2人仍需繳付2人費用參加,大小同價。

基本條款

- 参加者須於活動開始 10 分鐘前到達集合地點,並向在場職員出示確認報名電郵以核對身分。
- 2. 参加者必須準時於指定地點集合,逾時不候。
- 3. 所有已繳交之參加費用恕不退還。
- 4. 因任何情況缺席者,將被視為自願放棄活動,並不會獲任何其他安排。
- 5. 参加者須於活動開始前以本園提供之洗手液消毒,並於活動期間絕對遵從海洋公園員工之指示。
- 6. 参加者在課室內及幕後設施內不准拍照、錄影及使用手提電話。
- 7. 参加者應穿着合適衣著及密頭鞋子,請勿穿着拖鞋/涼鞋。
- 8. 請勿攜帶嬰兒車/手推車參與本活動。
- 9. 任何情況下,參加者均須絕對遵從海洋公園員工之指示。
- 10. 除得到本園導師批准外,所有參加者不得擅自離開團隊。
- 11. 如參加者在活動期間遺失或損毀本園財產,參加者須照價賠償。
- 12. 参加者必須監督同行兒童參加者,並對兒童參加者的安全負責。參與者亦須促使其兒童參加者遵守在場導師的指示
- 13. 参加者若作出對他本人或其他參加者構成危險或不安的行為,或不遵從本園導師發出的指引,本園會與參加者溝通並以合適的方法處理該參加者的行為問題。但若情況未見改善,本園會在適當情況下請參加者離開。本園不會對任何因行為問題而離開的參加者作出任何賠償。
- 14. 参加者入場須遵守海洋公園入口處所示之公園所有附例及安全規則。海洋公園對公園內任何人士之任何財物的任何種類之損失或任何損害概不承擔任何責任或負責。
- 15. 請勿攜帶貴重物品參與本活動,海洋公園對園內任何人士之任何種類之損失或任何損害概不承擔任何責任或負責。
- 16. 海洋公園有權更改活動內容而不作另行通知。
- 17. 海洋公園有權更改以上之參加者資格及條件,並無需另行通知。

報名方法及程序

- 1. 參加者必須於活動開始日前最少2天於網上報名
- 2. 活動名額採取先到先得形式 (以收到確認電郵為準),額滿即止。
- 3. 參加者必須提供正確聯絡資料,報名成功後,確認電郵將根據由參加者提供的聯絡資料而發出。





活動取消

- 因本園關閉以至本活動不能進行;或
- 有可能因以下情況取消:
 - i. 香港天文台發出黑色暴雨警告信號;
 - ii. 香港天文台發出八號或以上之熱帶氣旋警告信號;

Ocean Park Cable Car Rope RePLAYcement STEM Workshop Terms and Conditions

Criteria for Participation

- 1. Participants must be aged 6 or above.
- 2. Eligible participants aged 6-11 must be accompanied by a parent/guardian who satisfies all programme requirements. A parent/guardian can accompany a maximum of one eligible participants aged 6-11.
- 3. A valid admission ticket to the Park is required to join the programme. The price of the admission ticket is not included in the programme fee.
- 4. No accompanying guest is allowed (include children who are under aged 6).
- 5. All participants must complete and sign the Liability Release Form.
- 6. Eligible participants aged under 18 must have their parent/ guardian's signature on the Liability Release to confirm the detail before the programme starts.
- 7. The enrolment is on a 2-person basis. The pricing is the same for both adults and children. Participant group with less than 2 persons have to pay for 2-person full price.

General Conditions

- 1. Participants should arrive at the gathering location 10 minutes before the start of the programme, and to present the confirmation email to on-site staff for verification of identity.
- 2. Please arrive at the gathering point punctually. Late-comers might not be admitted to the programme.
- 3. All payments are non-refundable.
- 4. Participant absence in any circumstances is considered to have forfeited and no alternative arrangement will be provided.
- 5. Participants need to disinfect hands before workshop begins and must strictly follow every instruction given by the Park's staff to the satisfaction of the staff giving the instruction.
- 6. It is prohibited to take photo, video or use mobile phone inside the classroom or at the back-of-house of all facilities
- 7. Appropriate and comfortable-wear is recommended. Participant should wear closed toe shoes, please do not wear flip-flop/sandals. .
- 8. Please do not bring any trolleys/ strollers for the programme.
- 9. Participants must absolutely follow all the instructions given by Park staff at all times.
- 10. All participants are not allowed to leave the group without prior approval from the instructor.
- 11. If the Park's property is found lost or damaged during the programme, reimbursement in full cost must be made by the participant concerned.
- 12. Participants are required to supervise their children participant at all time and take responsibility for their safety. Participants are also required to procure them to comply with all Instructions provided by the programme tutor.
- 13. If a situation arises in which a participant threatens the safety or security of another participant, or if a participant shows disregard of programme guidelines, we will communicate with the parents and make every appropriate effort to handle the participant's behaviour. Should the disruptive behaviour continue, the participant may be dismissed from the programme and should leave the Park with his/her parents at the discretion of Ocean Park. The Park will not be held responsible for any cost associated with a child's dismissal on the ground of disruptive behavior.
- 14. A condition of entry is that participants must comply with all the Park's by-laws and safety rules, which are available at the entrance of Ocean Park. Ocean Park shall be under no liability or responsibility for loss of any kind or damage to any property of any person in the Park.
- 15. It is highly recommended that no valuable items should be brought to the Park. Ocean Park shall be under no liability or responsibility for any loss or any damage to the property of any participant in the Park.
- 16. The programme details are subjected to change at the discretion of the Ocean Park and without prior notice.
- 17. The criteria listed above are subject to change at the discretion of the Ocean Park and without prior notice.

Enrolment Method and Procedures

- 1. Enrolment must be made online at least 2 days before the programme date.
- 2. Application is accepted on a first-come-first-served basis, subject to availability (according to confirmation email).
- Applicant must provide accurate contact details. Confirmation email will be issued upon successful application, according to the provided contact details.





Cancellation

Cancellation of the Programme may be made in the following circumstances:

- Park closure or
 - i. A black rainstorm warning is issued by the Hong Kong Observatory;
 - ii. A Tropical Cyclone Warning Signal No. 8 or above is hoisted by the Hong Kong Observatory;
