Supply of Frozen Fish Feed - July 2026 to June 2028

Invitation for Expression of Interest in Supplying Frozen Fish Feed to Ocean Park Corporation Hong Kong from July 2026 to June 2028.

Ocean Park Corporation (the Corporation) invites interested parties to express interest in the supply of frozen fish feed at sufficient quantity and variety for the marine animals, penguins and fishes under the zoological collection. The Corporation is requesting the following species, including but not limited to, Capelin, Herring, Sardine, Silversides, Squid, Atlantic Surf Clam, Propeller Clam, Superba Krill, Bonito, Mackerel, Pacifica Krill, Silver Smelt, Night Smelt, Little Neck Clam, Blue Crab, Mysis, Saury, Lobster tail. Alternative species commonly accepted by other zoos and aquariums to feed marine animals, penguins and fishes will also be considered. The total estimated volume is 500 tonnes for two years.

Respondents are expected to submit the following information:

- (a) A list of available species.
- (b) A list of aquariums, animal facilities, theme parks or business related to human consumption served in the past five years and/or reference letters from the relevant clients.
- (c) Sustainability certificate (e.g., certificate(s) of achieving recognized standard(s) of sustainable seafood and/or are caught legally from managed fisheries; certificate(s) of origin with information on related government rules and regulations on sustainable fishery practice; relevant letters from seafood producer)
- (d) A letter of reference from the bank and audited financial statement of the last three years.

The expression of interest submission must be deposited into the tender box located at the Administration Building Annex of Ocean Park Corporation, Wong Chuk Hang Road, Aberdeen, Hong Kong SAR, China, on or before 3:30pm on 23 January 2026 (Hong Kong time). Late submissions will not be considered.

Expression of interest documents must be contained in a sealed envelope marked with the following details:

Submissions by fax or email will not be accepted.

The selection criteria include experience in the supply of frozen fish feed to aquariums or business related to human consumption, availability of required species, and selection of sustainable source/ managed fisheries. The Corporation will invite short-listed applicants to submit tender proposals in due course.

Respondents who do not hear from the Corporation within three months should consider their expression of interest unsuccessful.

After this expression of interest exercise, the Corporation reserves an absolute discretion to invite or not to invite any firm to submit tender proposals, or to execute the tender process or not.

## **Prevention of Bribery Ordinance**

Ocean Park Corporation is a public body listed under the Prevention of Bribery Ordinance, and it is an offence in law for anybody offering any form of advantages to the staff and agents (e.g., consultants) of the Corporation in connection with this Expression of Interest exercise or the subsequent tender exercise.

## Safeguarding National Security

Ocean Park Corporation may immediately terminate the Contract upon the occurrence of any of the following events [amongst other situations]:

- (a) the Supplier has engaged or is engaging in acts or activities that are likely to constitute or cause the occurrence of offences endangering national security or which would otherwise be contrary to the interest of national security;
- (b) the continued engagement of the Supplier or the continued performance of the Contract is contrary to the interest of national security; or
- (c) OPC reasonably believes that any of the events mentioned above is about to occur.
