

## Invitation for Expression of Interest

for

## Design and Implement of Parkwide Food and Beverage Point-of-Sale System

The Corporation invites expression of interest in undertaking a revamp project, Design and Implement of Parkwide Food and Beverage Point-of-Sale (hereafter F&B POS) System, that will provide a total solution from concept to deployment and from infrastructure to application.

In Ocean Park, F&B POS system has been running since year 2009. F&B business is operated in ways of cafeterias, restaurants, food kiosks and canteens. Total number of F&B POS endpoints is around 60. In coming years, the Park is going to establish new attractions, Hotels and Water World, the expansion will generate additional F&B POS endpoints in the new facilities for variety of Food and Beverage services. New F&B POS system must be armed with capacity for coming challenges and expandability to meet future growth.

New F&B POS system is designed as the best mixture of trend, technology and marketing that enhances guest experience and revenue growth on one hand, like Wireless Online Ordering and Payment, and improves operation efficiency and business analytic on the other hand, like Reservation System and Food Cost and Inventory Management.

- 5. Project management to ensure control of works and co-ordinations with other contractors and stakeholders; and
- 6. Audited financial statements from the last 3 financial years.

The proposal must be deposited into our tender box situated at the Administration Building Annex of Ocean Park, Aberdeen, Hong Kong, at or before 3.30 pm on 14 July 2017 (Hong Kong time). Late submission will not be considered.
