For safety reasons, please follow the rules and regulations in **H25**: Rising Fear.

1. 五歲以下之小童不可進入;五至十一歲的小童必須由十五歲或以上的人士陪同方可進入。 Children aged below 5 are not permitted to enter the attraction, children aged between 5 to 11 must be accompanied by a person aged 15 or above.

For your own safety and the safety of others, please do not run, push, sit, climb (except within designated scenes), remove or deface any interior facilities or touch our performers in the





attraction.

Water splash effects are installed inside the attraction; participants may get wet in the attraction. Ocean Park will not be responsible for any damage of personal items, including but not limited to clothing, cameras, phones etc. caused by the water splash effects in the attraction. For safekeeping, please use our locker service.
