





# 海洋公園 x 香港遊樂場協會 海洋生態及文化大使計劃 活動參加細則

### 甲部:參加資格及條件

- 1. 此活動適合 8 24 歲人士參加·主辦方並不建議未滿 8 歲人士參加本活動。每位未滿 18 歲之參加者必須由家長/監護人<sup>註1</sup>付費陪同參加。
- 2. 参加者必須懂得游泳,並能穿着衣服游泳最少50米。
- 3. 参加者如在活動前 24 小時內患有以下疾病,包括但不限於發燒、咳嗽、傷風/感冒、作嘔、腹瀉、嘔吐、皮疹、皮膚病、心臟病、肺病、血友病、腦癇症、接觸動物時出現暈浪、昏厥/眩暈/失去知覺徵狀、對動物或水有恐懼、或對魚敏感或免疫缺損者,主辦方並不建議參與本活動。
- 4. 参加者若感染預防及控制疾病條例(香港法例第 599 章)第一附表中載明之任何傳染病<sup>註 2</sup>·均不能參與本活動。
- 5. 參加者若身體不適,請留在家中休息,以保障所有參加者之安全。如有需要,主辦方亦會要求身體不適的參加者於活動進行期間離開。
- 6. 活動以廣東話進行。
- 7. 若參加者作出對他本人或其他參加者構成危險或不安的行為,或不遵從教練及主辦方職員發出的指引, 主辦方職員會在適當情況下請該參加者離開,該家長/監護人亦必須負責參加者之安全及行為。主辦方不 會對任何因行為問題而離開的參加者作出任何賠償。
- 8. 參加者不得在活動場地內行為不檢,亦不得作出淫褻或不雅行為。
- 9. 參加者必須能夠在遇上緊急事故時,於教練及主辦方職員的指示下迅速離開活動場地。
- **10.** 参加者須遵守所有場地的附例及安全規則。主辦方對任何參加者之任何財物及**/**或任何種類之損失或任何損害概不承擔任何責任或負責。
- 11. 在任何情況下,參加者均須絕對遵從教練及主辦方職員之指示。
- **12.** 教練及主辦方職員擁有最終權力決定任何參加者是否適合參與活動,並為確保安全或秩序之情況下,有權拒絕任何人士參與活動並不會安排退款、更改活動日期或任何賠償。

## 乙部:基本條款及報名須知

- 参加者須簽署水上活動同意/授權書及健康聲明·而未滿十八歲之參加者之同意/授權書則須由家長/ 監護人代為簽署·否則教練及本計劃職員有權拒絕參加者參與活動。

- 9. 本園可為參加者提供淋浴設施,惟本園不會提供風筒。
- 10. 本活動不接受隨行訪客(包括3歲以下小童)。

# Ocean Park x HKPA Marine Ambassador Programme Terms and Conditions

### **Section I: Criteria for Participation**

- 1. The programme is suitable for participants aged 8 to 24. Participants under 8 years old are not recommended. However, participants who are under 18 years old must be accompanied by a paying parent / guardian Remark 1 who satisfies all programme requirements.
- 2. The organiser only accepts participants who are able to swim 50 metres with light clothing on.
- 3. Participants suffering from any disease within a previous 24-hour time frame (including, but not limited to fever, cough, cold/flu, nausea, diarrhoea, vomiting, rash, skin disease, heart disease, lung disease, haemophilia, epilepsy, fainting/giddiness/loss of consciousness when in close contact with animals, phobia of water or animals, allergy to fish or depressed immune mechanisms) are not recommended to participate in this programme.
- 4. Participants must not be suffering from any infectious disease Remark 2 specified in the First Schedule to the Prevention and Control of Disease Ordinance (Cap 599 of the laws of Hong Kong).
- 5. To safeguard all participants, sick participants are requested to stay home. The organiser reserves the right to request the sick participants to leave the programme in case of such necessities.
- 6. The programme will be conducted in Cantonese.
- 7. If a situation arises where a participant threatens the safety or security of himself/herself or another participant, or if a participant shows disregard for programme guidelines, the participant may be dismissed from the programme at the discretion of Ocean Park. The participating parent/guardian shall have responsibility for the child's safety and behaviour at all times and is obliged to conduct himself or herself in such manner so as to achieve this. The organiser will not be responsible for any costs associated with a participant's dismissal on the grounds of disruptive behaviour.
- 8. Participants shall not behave otherwise than in an orderly manner in programme venue or behave in an obscene or indecent manner.
- 9. In case of emergency, participants must be able to quickly exit the activity venue under the guidance of staff and programme instructors.
- 10. A condition of entry is to comply with all the By-laws and safety rules of all venues. The organiser shall be under no liability or responsibility for any loss of any kind or any damage to any property of any person.
- 11. Participants must absolutely follow all the instructions given by the Park's staff and programme instructor at all times.
- 12. The Park's staff and programme instructor shall at all times have the full and final right to determine whether any participant is suitable for the programme and may refuse entry if refusal is necessary to ensure safety or order. Programme refund, reschedule or any compensation will not be arranged.
- 13. If the organiser's property is found lost or damaged during the programme, reimbursement in full cost must be made by the participant concerned.
- 14. The criteria listed above are subjected to change at the discretion of the organiser and without prior notice.
- 15. In case of bad weather and sea conditions during the activity, the Park's staff or programme instructor has the authority to suspend the activity. The organiser will not arrange for refunds, change of activity dates or any compensation.
- 16. Participants must comply with all By-laws and safety rules of the park as shown here when entering the area of Ocean Park and Water World. The organiser shall not be liable or responsible for any loss or damage of any property of any person in the Premises.

Remark 1: 'Guardian' has the same meaning as in the < Guardianship of Minors Ordinance >.

#### **Section II: General Information**

- 1. All participants must sign the Consent/Authorisation Form and Health Declaration Form for water sport. Those under 18 must have their forms signed by a parent or guardian. Otherwise, the coach and programme staff have the right to refuse the participant to take part in water activities.
- 2. The chosen programme date and participant's name cannot be changed upon confirmation, except under the circumstances stated in Section IV.
- 3. Please arrive at the gathering point punctually. Late-comers might not be admitted to the programme.
- 4. Programme will be carried out on the kayak/ in water. If participants are prone to seasickness or quick to feel unwell, please prepare your own medicines. The organiser will not provide any medication.
- 5. All participants are not allowed to leave the group without prior approval from the organiser's staff.
- 6. All participants must provide their full name (same as Hong Kong Identity Card/Passport) and last 4 digits of HKID/passport number for purchasing programme insurance. Participants must confirm that all information provided is genuine and correct. Participants will not be able to join the programme if they fail to purchase insurance due to incorrect or omissions of information.
- 7. It is highly recommended that no valuable items be brought to the venue. In the event that a participant's property is lost, damaged, or otherwise damaged, the organiser shall not be liable or responsible.
- 8. All participants are recommended to wear light clothing and bring their own change of clothes, water, hats, sunscreen, insect repellent and rain gear. While kayaking, participants must wear appropriate clothing the complies with the organiser's guidelines. For details, please refer to "Notes to Participants".
- 9. The organiser will provide showering facilities. Blow dryers will not be provided.
- 10. The activity does not accept accompanying visitors (including children under 3 years old).
- 11. The itinerary or content of the programme may be subject to change without prior notice.
- 12. The organiser will take photos or videos during the programme for any publicity or promotional materials. Other participants of the programme will also have access to these items.
- 13. We will take all practicable steps to destroy your personal data within a reasonable period of time. However, where you consent or do not object to the use of your personal data in direct marketing, we may continue to retain and use your personal data (primarily your name and contact details) in direct marketing product, service, activities and other, subjects until you opt out from direct marketing at any time.
