

海洋公園 (本園)  
探索歷險課程 – 漫趣探索行  
條款及細則

甲、參加者資格及條件

1. 漫趣探索行適合 9 至 11 小童參加。本園只接受能夠穿著輕便衣服游泳 50 米及踏水一分鐘之參加者參加本活動。
2. 參加者如在活動前 24 小時內患有以下疾病，包括但不限於發燒、咳嗽、傷風 / 感冒、作嘔、腹瀉、嘔吐、皮疹、皮膚病、心臟病、肺病、血友病、腦痲症、接觸動物時出現暈浪、昏厥 / 眩暈 / 失去知覺徵狀、對動物或水有恐懼、或對魚敏感或免疫缺損者，本園並不建議參與本活動。
3. 參加者若感染預防及控制疾病條例 ( 香港法例第 599 章 ) 第一附表中載明之任何傳染病<sup>註 1</sup>，均不能參與本活動。
4. 參加者若身體不適，請留在家中休息，以保障所有參加者之安全。如有需要，本園亦會要求身體不適的參加者於活動進行期間離開。
5. 參加者若作出對他本人或其他參加者構成危險或不妥的行為，或不遵從本園導師發出的指引，本園會與其家長溝通並以合適的方法處理該參加者的行為問題。但若情況未見改善，本園會在適當情況下請家長帶參加者離開。本園不會對任何因行為問題而離開的參加者作出任何賠償。
6. 參加者入場須遵守海洋公園入口處所示之公園所有的附例及安全規則。海洋公園對公園內任何人士之任何財物的任何種類之損失或任何損害概不承擔任何責任或負責。
7. 參加者必須能夠在遇上緊急事故時，於本園職員的指示下迅速離開活動場地。
8. 任何情況下，參加者均須絕對遵從海洋公園員工及活動導師之指示。
9. 如參加者在活動期間遺失或損毀本園財產，參加者須照價賠償。
10. 本園職員擁有最終權力決定任何參加者是否適合參與活動，並為確保安全或秩序之情況下，有權拒絕任何人士參與活動。
11. 本園有權更改以上之參加者資格及條件，並無需另外通知。

## 乙、基本條款

1. 每份報名表只供一位參加者報名一個活動。
2. 所有報名表必須由參加者之家長或家長授權的監護人（需年滿 18 歲或以上）清楚填寫。
3. 所有已繳交之參加費用恕不退還。
4. 除戊部及己部所列明之條款以外，報名一經確定，參加者不得轉換活動班別、日期、時間、餐飲選擇（如適用）或參加者姓名及電郵地址。
5. 參加者若有任何對食物敏感、特別健康狀況或其他需要注意的地方，請必須於報名時在「參加者資料 > 參加者是否對任何食品 / 物件 / 動物過敏？」內列明。如參加者之特別要求超越本園執行範圍，其申請將會不予接納。
6. 參加者必須準時於指定地點集合，逾時不候。
7. 工作人員將於活動當日以參加者之姓名及電郵確定信核對。
8. 除得到本園導師及活動導師批准外，所有參加者不得擅自離開團隊。
9. 請勿攜帶貴重物品參與本活動，海洋公園對園內任何人士之任何種類之損失或任何損害概不承擔任何責任或負責。
10. 請各參加者穿著輕便服裝，自備日常用品（如牙膏、牙刷、沐浴物品、毛巾）、更換衣物、水、帽子、防曬用品、防蚊用品及雨具。必要時請帶備禦寒衣物。於進行水上活動時，參加者必須穿著合乎本園指引的合適服裝。
11. 本園可為參加者提供淋浴設施，惟本園不會提供風筒。
12. 參加者在幕後設施內不准拍照、錄影及使用手提電話。
13. 參加者於完成活動後必須由家長或家長授權的監護人（需年滿 18 歲或以上）接送。
14. 活動費用已包括參加者最後一天的留園費用及一張日間成人入場贈券於活動最後一天使用。
15. 本活動不接受隨行訪客（包括 3 歲以下小童）。
16. 海洋公園會於活動期間為參加者拍攝照片或影片，以作推廣或紀錄之用途；該活動之其他家長或參加者亦有機會查閱是次活動所拍攝之內容。

## 丙、報名方法及程序

報名必須於活動日最少 7 日前於網上遞交。活動名額先到先得，額滿即止。報名成功完成後會即時收到電郵確定信，請留意確定信有否被誤標示為垃圾郵件。

## 丁、活動優惠及報名

1. 早鳥優惠
  - i. 參加者於指定早鳥優惠時段可享課程費用折扣。此優惠不可與其他推廣優惠共用。

## 戊、活動更改或取消

1. 本園擁有最終決定權即時終止或取消活動。
2. 若報名人數不足，本園有權取消或更改活動日期。
3. 所有活動行程或內容如有更改，恕不另行通知。

## Ocean Park (The Park) Adventure Series –“Voyagers”

### Terms and Conditions

#### (A) Criteria for Participation

1. “Voyagers” is suitable for children aged 9 to 11. The Park only accepts participants who are able to swim 50 metres with light clothing on and able to tread water for one minute.
2. Participants suffering from any disease within a previous 24-hour time frame (including, but not limited to fever, cough, cold/flu, nausea, diarrhea, vomiting, rash, skin disease, heart disease, lung disease, haemophilia, epilepsy, fainting/giddiness/loss of consciousness when in close contact with animals, phobia of water or animals, allergy to fish or depressed immune mechanisms) are not recommended to participate in this programme.
3. Participants suffering from any infectious disease specified in the First Schedule to the Prevention and Control of Disease Ordinance (Cap 599 of the laws of Hong Kong) <sup>Remark 1</sup> will not be allowed to take part in this programme.
4. To safeguard all participants, sick participants will be requested to stay home. Ocean Park reserves the right to request sick participants to leave the programme in case of such necessities.
5. If a situation arises where a participant threatens the safety or security of other participants, or if a participant shows disregard of programme guidelines, we will make every appropriate effort to communicate with the parents to handle the participant’s behaviour. Should the disruptive behaviour continue, the participant may be dismissed from the programme and should leave the Park with his/her parents at the discretion of Ocean Park. The Park will not be held responsible for any cost associated with a child’s dismissal on the ground of disruptive behaviour.
6. A condition of entry is to comply with all the park’s By-laws and safety rules which are available at the entrance of Ocean Park. Ocean Park shall be under no liability or responsibility for any loss of any kind or any damage to any property of any person in the Park.
7. In case of emergency, participants must be able to quickly exit the activity venue under the guidance of Park’s staff.
8. Participants must absolutely follow all the instructions given by the Park’s staff and activity instructors at all times.
9. If the Park’s property is found lost or damaged during the programme, reimbursement in full cost must be made by the participant concerned.
10. The Park’s staff shall at all times have the full and final right to determine whether any participant is suitable for the programme and may refuse entry if refusal is necessary to ensure safety or order.
11. The criteria listed above are subject to change at the discretion of the Park and without prior notice.

## (B) General Conditions

1. One enrolment form is for one participant and one programme only.
2. All enrolment documents should be clearly filled in by the parent or the authorized guardian (aged 18 or above).
3. All payments made are non-refundable.
4. The chosen programme code, date, time, meal's selection (if applicable) and participant's name and email cannot be changed upon confirmation, except the circumstances stated in Part (E) and Part (F).
5. Should the participant have any food allergy, special medical condition or require special attention, please specify them clearly in the Participant Information field, "Is participant allergic to certain food/ objects/ animals?" Enrolment will not be accepted if the special request exceeds the operational scope of Ocean Park.
6. Please arrive at the gathering point punctually. Late-comer might not be admitted to the programme.
7. Participant's name and the email of confirmation letter should be presented for verification on the programme date.
8. All participants are not allowed to leave the group without prior approval from the instructor.
9. It is highly recommended that no valuable items should be brought to the Park. Ocean Park shall be under no liability or responsibility for any loss or any damage to the property of any participant in the Park.
10. All participants are recommended to wear casual outfit and bring daily necessities (e.g. toothbrush, toothpaste, shower items and towel), clothes for changing, a bottle of water, hat/ cap, sunscreen lotion, mosquito repellent and umbrella. Participants may also bring along coats if necessary. During water-based activities, participants must wear appropriate outfit that fits our guidelines.
11. The Park provides shower facilities for participants, however hair dryers are not included.
12. It is prohibited to take photo, video or use mobile phone at the back-of-house of all animal facilities.
13. Participant must be picked up by his/her parents, or the authorized person (aged 18 or above) at the end of programme.
14. The Programme Fee includes the participant stay-behind surcharge on the last day of the programme and one complimentary daytime adult admission ticket on the last day of the programme.
15. No accompanying guest is allowed (include children who are under age of 3).
16. Ocean Park Corporation will take photos or videos during the Adventure programme for any publicity or promotional materials of Ocean Park. Other participants or parents of children joining the Adventure programme will also have access to these items.

## (C) Enrolment Method & Procedures

Enrolment must be made online at least 7 days before the first day of programme. Enrolment will be considered on a first-come-first-serve basis. A confirmation letter will be sent via email once the payment has been received. Please also pay attention if the confirmation letter was wrongly identified as spam or junk mail.

## (D) Privileges and Enrolment

1. Early Bird Privilege
  - i. Participant could enjoy a special discount on programme fee within the specified period of Early Bird Privilege. This offer cannot be used in conjunction with other promotional offers.

## (E) Cancellation and Changes of Programme

1. Decision for immediate cancellation of the programme shall be at the sole discretion of Ocean Park.
2. If there is insufficient enrolment, we reserve the right to cancel or arrange another programme date for the participant.
3. The itinerary or content of the programme may be subject to change without prior notice.
4. Programme will be cancelled under the following circumstances. Instructors will contact parents about the arrangement in such cases of adverse weather during the programme period. You are also welcomed to check with the “Special Circumstances & Weather Arrangement” in the Park’s website for further details: :
  - i. A red or black rainstorm warning is issued by the Hong Kong Observatory;
  - ii. A Tropical Cyclone Warning Signal No. 3 or above is hoisted by the Hong Kong Observatory;

5. When the programmes will be cancelled, parents should take the participants home even when they are on the way. Ocean Park will arrange staff to look after participants who might have already arrived.

6. The park would make the following arrangements for the programmes that are decided to be cancelled by the Park:
- Cancelled programmes will not be postponed to the next programme day. Future activities will accord with the original time and date.
  - Detailed reschedule or refund arrangements will be arranged by email or via phone within 7 working days after the cancellation of a programme.
  - A partial refund can be arranged in proportion to the affected number of days or programme content. A partial refund can be arranged if medical certificate with the designated programme date of the participant could be provided.
