Am I required to receive COVID-19 vaccine prior to my visit to Water World?

According to Hong Kong Government's announcement, except the individuals who are issued with a COVID-19 Vaccination Medical Exemption Certificate, visitors aged 12 or above are required to fulfill the vaccination requirements of the Vaccine Pass for visiting Water World. The vaccination requirements under Vaccine Pass are as follow:

有關網上預約入園、使用「安心出行」及出示「疫苗通行證」相關紀錄的概要,可參考以下列表:

I have made online reservation for my coming visit. Upon arrival at the Park, am I still required to scan the LeaveHomeSafe QR code at the Park entrance?

To comply with the Hong Kong Government's latest anti-pandemic guidelines, all visitors are required to use the "LeaveHomeSafe" app to scan the venue QR code before entering Water World, except the following 3 categories of persons may fill in a specified form as an alternative:

- (i) Persons aged 65 or above and aged 15 or below
- (ii) Persons with disability

(iii) Other persons recognized by the Government or organization(s) authorized by the Government.

People aged 15 or below would not have to register his or her personal information using the specified form if he or she is accompanied by an adult who has complied with the LeaveHomeSafe requirement.

The "LeaveHomeSafe" exempted persons are required to register their name, contact number and visiting date and time. The respective identity document must be presented to our staff for verification purpose.

	QR code is only valid for one-time entry, all registrants must enter the Park at the same time.

	What should I do if I need to exit the Park for a while and re-enter within the day? Do I need to make another reservation or scan the LeaveHomeSafe QR code again for my re-entry? No, you do not need to make another online reservation for re-entry, but you are required to use the "LeaveHomeSafe" app to scan the venue QR code (or use the specified form to register relevant information as an alternative in accordance with the requirement) before entering Water World. Before you leave the Park, please approach our staff member at turnstile and you will be given a wristband. Then, you can present your wristband and the admission ticket / pass for re-entry verification.
